Eligibility - Who may Enter: Sweepstakes is open to legal residents of the 50 United States and D.C. only, who are age 18 or older as of date of entry, and have a valid U.S. driver's license or government issued identification, except the following persons who are not eligible to enter or win:

Determination of Prize Winner: As of 6/27/16 at 8:00:00 am, all participant submissions will be collected by sponsor. ONE participant will be randomly selected from the pool of submissions using a random number generator.

Conditions for all Prize Winners: During the prize winner notification process, the potential prize winner must confirm their eligibility, and indicate their willingness to accept the prize award (see prize description below).
